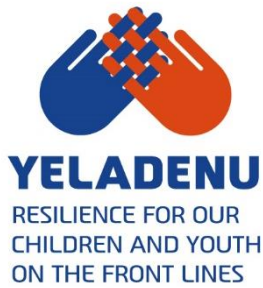

Please tell your donors to send us an email asking for our wire instructions. We must have a direct series of emails with the donors to ensure that we can identify the funds properly and acknowledge the donors correctly.

To transfer funds:

By wire-transfer or check in the US (including in case of a donation through a Donor Advised Fund):

1. The donor must first make the donation on the website and choose check/wire/JCF as the payment method.
2. The donor will then receive a reference code and be asked to contact our support at support@jgive.com with an identification document.
3. After we've received an identification document (could be a passport, id, driver's license, etc.), we will send you the donor details in the US.

4. When the donor sends the check or makes the transfer, they must make sure to attach the reference code they received to the transfer.

It is crucial to follow these steps and include the reference code received on the website in the transfer itself.
